## TERMS & CONDITIONS OF PARTICIPATIONS FOR EXHIBITOR

1. The Exhibition shall mean **ASIA FOODTECH 2019 Gandhi Maida, Patna, Bihar** the exhibitor shall mean any party to whom stall been allotted at the Exhibition, and the ORGANISER shall mean the management of **SGS INTERNATIONAL**
2. Stall are allotted to Exhibitors are not transferable and subletting in full or part to third party is strictly prohibited.
3. The exhibitors are responsible for any statutory obligations such as sales tax, trade license etc.
4. All the submissions of the Application forms duly signed as acceptance as well as further rules circulated by the organizer from time to time.
5. Stalls will be allotted by the organizer on receipt of duly filled in Application & contract form along with advance payment of 50% of pay amount. Balance payment must be completed latest by **10<sup>th</sup> October 2019**.
6. All payment must be made by cheque /DD in favour of **SGS INTERNATIONAL**
7. The exhibitors are advised to take insurance cover against all risks from the date of taking possession of their stalls to the date of taking possession of their stalls to the date of vacating the hall. The organizers are expressly indemnified by the exhibitor's respect of any loss or damage to their goods and injury to staff, as well as third party claims.
8. Standard modular furnished stall (9 Sqm) comprises side and rear wall panels, carpet for floor area, one table, two chair, three spotlight, one 5 Amp. Socket, one waste basket & fascia with company's name. Additional furniture or electrical fittings are available on extra cost.
9. Painting, pasting papers which cannot be removed or making holes by nailing etc. on the wall panels or furniture supplied by our contractors are prohibited. The maximum compensation shall be the replacement cost of the panels/ furniture.
10. The organizer reserves the right to photograph any stalls for their use.
11. Any kind of legal arbitration should be solved only in New Delhi.
12. Immediately after close of the exhibition dismantling will starts and all exhibitors must remove their goods during the same night, failing which the organizer shall not responsible for any consequence.
13. The organizer reserves the right to change floor plan, add or delete some of the passages, reallocate stalls. Organizer's decision in these matters shall be final, and this will not be sufficient ground for any exhibitor to cancel participation & claim refund. further more, the exhibitors clearly indemnify the organizer against all claims. Costs or damage arising from these charges as well, due to any power failure during the exhibition period.
14. **SGS INTERNATIONAL** maintains an 80 decibel sound level for all exhibitors. This level has been identified as being a safe level for B2B Show demonstrations. To endure a successful a safe B2B show for all exhibiting companions and their guests, **SGS INTERNATIONAL** as show Management, reserves the right to closely monitor usage and, where necessary, restrict and possibly eliminate the music/musical instruments and other audio demonstration in an exhibitor, booth at its discretion. Show Management actions can include, but are not limited to, reviewing and adjusting all sound system and loud-speaker placements within an exhibit, restricting sound levels within a booth, and restricting demonstrations within a booth, and restricting demonstrations within a booth.
15. Full Security Guard will be deployed from the 1<sup>st</sup> day of the show on morning, general security will be arranged by the organizer but Exhibitors are open to keep their own Security guard for night shift.
16. The organizers shall have full authority during the occupancy of venue for the exhibition and all decisions of the organizers shall be final and binding to all exhibitors and their staff or agent.
17. In case of cancellation of stall booking due to whatsoever the reason, total payment made by the exhibitor shall be forfeited. If after allotment of stall, an exhibitor does not make the balance payment by **10<sup>th</sup> October 2019** his booking will be treated as cancelled and advance payment will be forfeited.
18. The Exhibition may be postponed/ shortened due to any cause whatsoever beyond the control of the organizers. The organizer shall not be responsible for any loss sustained by the exhibitors directly or indirectly, attributable to the elements of nature, force majeure or orders or directives imposed by any Governmental authorities. In such circumstances, the money paid by the exhibitors or any part thereof may be refunded at the sole discretion of the Organizer.
